Division The return form allows a registered person to
lodge a Value Added Tax (VAT) return, either monthly,
quarterly or annually, as required by the VAT Act. Please
note that if you are required to register under the VAT Act,
you must register before you complete the return. You can
register by completing the Application for Registration
form, and lodge
